The Receiver reserves his right to amend this determination based on further investigation of the information held by the Receiver, the discovery of additional information, or any other reasonable basis.

Your Right to Object.

The determination above is based upon the Receivership Defendant's current information and the information you submitted in the Claims Process. You have the right to object to this determination. **If you disagree** with this Claim Determination, you must file a written opposition in the manner described below within 30 days of the date of this Claim Determination. **Unless such opposition is timely filed, this determination will be final and binding.** To object, you **MUST** electronically file an objection including your Claim Portal Registration ID and any corresponding ZeekRewards username(s) within **30 DAYS** of the date of this Claim Determination. Your opposition **MUST** set forth (1) the claim number(s) listed above; (2) a detailed statement of the reasons for your objection to this Claim Determination, including specific references to documents supporting your claim calculation; (3) copies of any document that you rely upon that were not previously uploaded as part of your claim; and (4) how to contact you by regular mail, phone, and electronic mail. **If you do not file opposition papers within 30 days of the date of this letter, the present determination will be considered final.**

Provided that you file and serve a timely written objection, the Receiver will take action to resolve the dispute and request resolution through a Court-approved process if necessary.

- You may also contact a representative of the Receiver to discuss and possibly resolve any difference between the amount that you claimed and the amount that the Receiver allowed. **To contact a representative, please send an e-mail to claims@zeekrewardsreceivership.com.**

If You Agree with the Claim Determination.

If you agree with this determination, you must still provide the Receiver with the Declaration and Release if you would like to receive a pro rata share on account of your claim. If you accept the Claim Determination, please sign into the Receiver's Claim Portal to provide the required payment instruction information and submit the Declaration and Release (the "Release"). A copy of the Release is attached to this Claim Determination for your review. **Retain a copy of the Release and this Claim Determination for your records.**

Please read the Release carefully before you submit it. Among other provisions, the Release requires you to confirm, under penalty of perjury, that you have not received any payments or transfers of the Claim Amount except for the amount already transferred to you that is noted above.

The Receiver will not make any distributions of the Claim Amount to you unless you submit the enclosed Release on the Receiver's Claim Portal. Failure to submit the Release may forfeit any distribution you would receive on account of your claim.
